HEALTH/RECREATION CENTER

Built in 2004, this center is a state of the art fitness facility. The offering includes exercise equipment/weight training area, locker room, showers, full sized gym, basketball, volleyball, community leagues, exercise classes, indoor health fairs and community group gatherings.

The gym is ready for basketball, volleyball, shuffleboard and other various athletic activities. Also located within, a heated indoor exercise pool and spa for cool summer and winter days. Game room with pool tables, arcade and vending machines.

3 outdoor pools (General Pool, Adult Pool, Kiddie Pool) are available during the summer season. The main pool features a winding water slide and a diving board.

WRWSD Fees

Annual WRWSD fees are **billed annually on April 1st** and are due within 30 days thereof. Monthly water and sewer usage statements are billed on the 1st of the month for the previous month's usage and is due on the last day of the month.
