# Major Accomplishments of April 2024 – March 2025

Thanks to the work and dedication of the WRWSD plant manager and crew both at the plant and in the office in the last 12 months we have:

- Delivered a quality product and service (water and sewer) to the community and fixed various leaks and breaks throughout the year in a timely manner.
- Started PFAS ('forever chemical') testing per ODNR requirements.
- Got our new class 3 operator, plant manager Greg Wilson, on board.
- > Dan Pike, our sewer supervisor, earned his class 1 water distribution license.
- Water tower was painted.
- > Water monitoring device installed on the water tower.
- > RFQ process for sewer expansion began.
- > Consumer Confidence Report (CCR) completed.
- OSHA training tracking was improved.
- "Auditor of State Award" received from Ohio House of Representatives for timely, accurate, and comprehensive financial statements.
- Held a plant tour, open to the community, on Aug. 17, 2024.
- > 15-year CIP program drafted up.
- Prioritized equipment purchasing needs.
- New boring machine was purchased.
- > Tracking program for fire hydrant flushing was established.
- > Provided advance notice of the need to increase sewer reserves for the upcoming sewer expansion project,
- > Established a rough timeline for the sewer expansion project.
- Switched consultants for the sewer expansion project to one more familiar with newer possible technologies which might be of benefit to the community.
